Boat ramp gate will be secured using two locks starting March 1, 2023, one from the prior year, and the other will be the 2023 lock. The new lock for the 2023 membership year will be our new fob-operated lock, and the prior year's key for 2022 will operate the *blue* lock on the left. The boat ramp will be secured in this manner until March 31. Effective **April 1, 2023**, only the lock for the 2023 year will remain. **On the new fob operated lock, there is a power button on the bottom of the lock. To open, just push the power button and you will see the face of the lock start blinking. Then, just hold your fob to the face and the lock will beep and flash. At this point the lock can be opened.** The fob lock has been placed within an enclosure to help shield it from the weather. Please be sure to close the cover once you're done accessing the ramp.

To obtain the new fob, a prior year member must be in good standing (dues fully paid for the membership year), complete a "key request form" and have the old key to trade. Members who do not have the old key can obtain a fob by paying a \$20 key replacement fee. New members can obtain a boat ramp gate key by completing a "key request form".

**Board Policy regarding the use of the Boat Ramp and Association Owned Lot #51**

Use of this boat ramp and picnic area is limited to paid members only.

Regulations apply:

1. Swimming is not permitted.
2. Use of the boat ramp and picnic area is prohibited between the hours of 10p.m. and 5 a.m.
3. Gate fob is to be used only by paid members and not lent or given to non paid members.
4. Guests may use the boat ramp and park if accompanied by a member. Members are responsible for the conduct and any damages caused by their guests.
5. Children shall be accompanied by an adult while in the immediate vicinity of the boat ramp or on the dock.
6. No motorized vehicle is to be driven onto the lot by children under 16 years of age without an adult.
7. No power loading of boat onto trailers
8. Unattended parking of vehicles or trailers is prohibited.
9. Fires shall be supervised by an adult.
10. All waste and debris shall be removed after use of property.
11. Gate shall be closed and locked upon departure.
12. Violators of these regulations are subject to arrest and prosecution.
