2024 Boat Ramp Key Application

The keyholder acknowledges and agrees to follow the rules and regulations of this agreement associated with access and use of the ESPOA owned Pavilion Lot and Boat Ramp.

- The privilege of having a key is restricted to members in good standing who have paid the annual assessment to ESPOA.
- To surrender their key when they are no longer a property owner within the association.
- To surrender their key if they do not elect to keep their annual assessment current.
- To relock the gate as soon as possible after exiting from the boat ramp.
- To properly dispose of trash after use of the ramp or pavilion.
- To pay a \$20.00 fee whenever a key is lost or misplaced.
- To help preserve the quality of the boat ramp by not "power loading" their boat so as to not erode or wash out the underwater rock portion of the ramp.
- Swimming is not permitted.
- Use of the boat ramp and picnic area is prohibited between the hours of 10 p.m. and 5 a.m.
- Guests may use the boat ramp if accompanied by a member.
- Unattended parking of vehicles or trailers is prohibited.
- Children shall be accompanied by an adult while in the immediate vicinity of the boat ramp or on the dock.
- Fires shall be supervised by an adult and fully extinguished before leaving.

The privileged use of the boat ramp and pavilion area are for the sole use of the members in good standing and members of their household. Violations of this agreement include leaving the gate unlocked or loaning the key to a non-member or member who is not in good standing with ESPOA. Violations of this agreement may result in the revocation of privileged use and demand for the keys to be returned to the association.
